

Discrimination is Against the Law

Winnebago Comprehensive Healthcare System ("WCHS"), including Twelve Clans Unity Hospital and Winnebago Public Health Department, complies with applicable Federal civil rights laws and does not discriminate on the basis of race, color, national origin, age, disability, or gender.
